#### MIN. 1/AGM/2018: ADOPTION OF AGENDA

- 4. To approve and declare a final dividend of UGX 1 per share for the year ended 31 December 2017.
- 5. To rotate and elect Directors in accordance with the Articles of Association of the Company and determine their remuneration.
- 6. To re-appoint M/s Jim Roberts & Associates as auditors for the year ending 31 December 2018 and authorise the Directors to fix their remuneration.
- 7. To consider any other business for which notice has been given to the Secretary at least 48 hours before the meeting.

#### MIN. 2/AGM/2018: MINUTES OF PREVIOUS ANNUAL GENERAL MEETING

2. The meeting considered the minutes of the Annual General Meeting held on the 7th of July 2017 and adopted them as a true record of the meeting, save for some corrections in the names and contact details of those who attended.

MIN. 3/AGM/2018: TO RECEIVE AND CONSIDER THE DIRECTORS' REPORT AND AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2017 TOGETHER WITH THE REPORT OF THE AUDITORS

3 The Directors' report, audited financial statements for the year ended 31 December 2017 and the report of the Auditors were presented as follows:

#### 3.1 Chairman's Statement

The Chairman presented his statement on pages 14 to 16 of the Annual Report and highlighted the following:

**3..1.1** The Company made a net profit of UGX 2,395,217,000/=. This was largely driven by emphasis on production and sale of fast-moving products and reduction of the cost of production.

The Company was therefore able to declare a dividend of UGX 1 per share for the year ended December 2017.

- 3.1.2 The Company had continued to pursue compensation from the Government of Uganda and the Uganda National Roads Authority (UNRA) for land compulsorily acquired at Kajjansi for construction of the Kampala-Entebbe Express Way/ Munyonyo Spur. The Company had filed a case in the High Court Land Division which was pending hearing. UNRA had paid partial compensation for the surface value of the land and was disputing the claim for economic loss.
- **3.1.3** The Company had lost one of its Directors Dr. Ijuka Kabumba who passed away on 22-12-2017. He had diligently served the Company as Director for many years.

#### 3.2 Managing Director's Statement

The Managing Director presented his statement on pages 18-24 of the Annual Report and the following were the key highlights:

- 3.2.1 The Company's revenue for the year increased from UGX 26 billion in 2016 to UGX 27.2 billion in 2017, representing a growth of 4.5%.
- 3.2.2 The Company's overheads increased by 21% due to intensified marketing activities to grow revenues by opening up new outlets in priority markets, and enhancement of staff remuneration to support continuous productivity.
- 3.2.3 The main challenges and risks to Company included reduced clay reserves due to loss of land to UNRA for the expressway, optimization of Kamonkoli plant, the growing number of competitors in an unregulated environment and the outstanding shareholder loan of UGX 20.6 billion owed to NSSF and the planned debt-equity conversion.
- 3.2.4 The Company would seek to optimize and modernize the Kamonkoli factory. The Company would acquire more clay reserves and restore the environment wherever clay was extracted.
- **3.2.5** The Company would continue to focus on growing the top line by increasing sales volumes and improving distribution.

#### 3.3 Directors' Report

The Company Secretary presented the Directors' report on pages 34-53 of the Annual Report. The Directors recommended payment of a dividend of UGX 1 per share for the year ended 31st December 2017.

#### 3.4 Report and Opinion of External Auditors

The report and opinion of the external auditors M/s Jim Roberts & Associates was presented by Mr. Julius Okurut. According to the report and opinion which was unqualified:

3.4.1 The financial statements presented fairly, in all material aspects, the financial position of Uganda Clays Limited as at 31st December 2017, and its financial performance and cash flows for the year ended. The financial statements were in accordance with International Financial Reporting Standards and the requirements of the Companies Act, 2012.

3.4.2 The external auditors had obtained all the information and explanations necessary for the audit and in their opinion proper books of account had been kept by the Company and the Company's statement of financial position and statement of profit and loss were in agreement with the books of account.

#### 3.5 Financial Statements

The Head of Finance presented the audited financial statements of the Company for the year ended 31st December 2017, with the following highlights:

- **3.5.1** The total revenue for the year was UGX 27,201,533,000/= compared to UGX 26,037,358,000/= in 2016.
- **3.5.2** The gross profit was UGX 10,690,742,000/=.
- **3.5.3** The total expenses were UGX 10.999.277.000/=.
- **3.5.4** The Company made a net profit of UGX 2,395,217,000/= compared to a profit of UGX 2,373,375,000/= in 2016.

#### 3.6 Reactions from Members

Some of the members raised queries from the various reports presented which were answered as follows:

Query 1:	A member wondered whether the perennial tribal clashes at Kamonkoli affect the perfor-
	mance of the Kamonkoli factory.

The Managing Director assured the meeting that the clashes have not affected the operations Answer: of Kamonkoli factory.

Query 2: A member asked whether there was quality assurance at Kamonkoli factory given the market perception about the quality of products from there.

The Managing Director assured the meeting that there were sufficient quality controls for Answer: products from both factories at Kamonkoli and Kajjansi and that products from both factories were all of high quality.

Query 3: A member inquired about the progress of the proposed debt-equity conversion for the NSSF

The Managing Director informed the meeting that the process was still ongoing and would Answer: involve the introduction of a strategic investor. A suitable strategic investor had not yet been identified.

A member wondered why some of the compensation received from Uganda National Roads Ouerv 4: Authority [UNRA] was not used to pay a dividend to shareholders.

The Managing Director informed the meeting that the compensation so far received from UNRA was approximately UGX 3 billion and was for the surface value of the land only. Most of the money had been used to pay off the commercial loan owed to Standard Chartered Bank and the East African Development Bank. The balance was used to purchase some spares for the factory lines. The Company was still pursuing compensation for economic loss. If substantial compensation for economic loss is received, the Board of Directors will consider whether to use some of the money to pay a special dividend to the shareholders.

Query 5: A member wondered whether the Company was prioritizing the acquisition of more clay reserves after the loss of substantial clay to the Munyonyo express way.

The Managing Director informed the meeting that the Company had already acquired some Answer: 30 acres of land with clay in the vicinity of the Kajjansi factory and was exploring opportunities to acquire more land where available.

A member pointed out that the debt owed to the NSSF was stated as UGX 23 billion in the Query 6: financial statements and UGX 20.3 in the Managing Director's statement and sought an explanation for the discrepancy.

Answer: The Head of Finance explained that the loan and interest had been capped by the NSSF at UGX 20.3 and UGX 23 billion was the amount if interest continued to be charged.

A member inquired about which assets had been disposed off as stated in the financial state-Query 7: ments and asked why the statement of cash flows does not reflect the disposal.

> The Head of Finance explained that the asset disposals were mainly for old vehicles and that was no corresponding entry in the statement of cash flows because was payment was not immediate but the disposal had been recognized in the movement of trade and other receivables.

A member wondered why the provisions for bad debts had increased and wanted to know Query 8: whether the Company was giving out loans to some people.

> The Head of Finance explained that the debts arose as a result of selling some products on credit. The debts being written off had been pending for over five years. Debt collection was ongoing and the Company had introduced a strict policy for sales on credit to minimize default.

A member advised that the Company should put in place mechanisms to ensure that the Query 9: Company's products are available throughout the country in order to increase sales and grow revenues.

The Managing Director informed the meeting that the Company was continuing to sign up agents country-wide to boost the distribution of the Company's products and thereby increase sales. In addition, the Company was addressing the question of product availability.

#### Adoption of Financial Statements and Reports

The meeting unanimously resolved to adopt the financial statements for the year ended 31st December 2017 and all the reports in the Annual Report.

### MIN. 4/AGM/2018: TO APPROVE AND DECLARE A FINAL DIVIDEND OF UGX 1 PER SHARE FOR THE YEAR ENDED 31 DECEMBER 2017

- 4.1 The Directors proposed a declaration of a dividend of UGX 1 per share for the year ended 31 December 2017 to be paid out of a net profit of UGX 2,395,217,000/= for the year.
- 4.2 The members considered and unanimously approved the proposed dividend of UGX 1 per share for the year ended 31 December 2017.

#### MIN. 5/AGM/2018: ROTATION AND ELECTION OF DIRECTORS

- 5. The Company Secretary informed the meeting that:
- According to article 69 of the Company's Articles of Association, one half of the Directors [excluding the Managing Director] retires every year but are eligible for re-election. The Directors to retire every year are those that have been longest in office. There are currently nine Directors after the demise of Dr. Ijuka Kabumba, although the maximum number allowed under article 69 is ten.
- 5.2 According to the dates of appointment, the Directors due to retire but were eligible for re-election were: Dr. Martin Aliker, Mr. Joseph Tukuratiire, Eng. Martin S Kasekende, and Dr. Ijuka Kabumba but who had passed away on 22-12-2017. Dr. Martin Aliker, Eng. Martin Kasekende and Mr. Joseph Tukuratiire, the retiring Directors, expressed willingness to continue in office. The Board of Directors recommended their re-election.
- 5.3 The retiring Directors, save for the deceased Director, were individually presented to the shareholders for re-election as follows:
- i Dr. Martin Aliker was proposed for re-election and the meeting voted to re-elect him as a Director.
- ii Mr. Joseph Tukuratiire was proposed for re-election and the meeting voted to re-elect him as a Director.
- iii Eng. Martin Kasekende was proposed for re-election and the meeting voted to re-elected him as a Director.
- 5.4 The Chairman informed the meeting that the remaining position on the Board which had been held by the late Dr. Ijuka Kabumba would be filled at the next Annual General Meeting because there were still ongoing consultations for suitable candidates.

5.5 The Chairman informed the meeting that this was the last time he was chairing the Annual General Meeting of the Company. In fulfilment of his earlier pledge that he would quit as soon as the Company returned to profitability, he was going to resign at the next Board meeting and the remaining members of the Board would elect a new Chairman. He thanked the shareholders for the confidence placed in him as a Director and Chairman of the Company and for the cooperation received through the years.

### MIN. 6/AGM/2018: TO RE-APPOINT M/S JIM ROBERTS & ASSOCIATES AS AUDITORS FOR THE YEAR ENDING 31 DECEMBER 2018 AND AUTHORISE THE DIRECTORS TO FIX THEIR REMUNERATION

- **6.** The Company Secretary informed the meeting informed that:
- According to the Company's Articles of Association, external auditors were appointed annually in a general meeting. The current external auditors of the Company are Jim Roberts & Associates, Certified Public Accounts who were first appointed at the AGM of 17-10-2014 and were re-appointed in the last AGMs of 9-12-2015, 9-12-2016 and 7-7-2017. They have provided external audit services to the Company in respect of the financial years 2014, 2015, 2016 and 2017.
- 6.1.2 Their fees were negotiated and agreed at UGX 30,050,000 (Uganda shillings thirty million fifty thousand only), inclusive of all disbursements but are exclusive of VAT.
- 6.1.3 M/s Jim Roberts & Associates had expressed willingness to continue in office. The auditors had rendered satisfactory services to the Company and the Board of Directors had recommended their re-appointment as auditors for the financial year 2018 and to authorise the Board of Directors to fix their remuneration.
- **6.1.4** The meeting unanimously resolved to re-appoint Jim Roberts & Associates as the Company's external auditors for the year ending 31st December 2018.
- **6.1.5** The meeting further resolved to authorize the Directors of the Company to negotiate and fix remuneration of the external auditors.




